



Incentive Manager – activity tracker open – today's date





User opens activity tracker.

Point value of fitness activity on each day will be displayed in the lower right corner of the calendar date.

By clicking on the date, the user will see what app(s) powered points for that date. By clicking on the "View my daily fitness activities" button, he can see details of fitness activity performed on that day in the fitness profile.

On left hand side, user can see total points earned for the program (from processed data).

We added text to let the user know they are viewing goal "XX of XX" and made the right and left arrows more visible.

By clicking the "In Progress" button, the user is taking to the goal profile page where he can see any goals in progress. When there are no goals in progress, the button says "Start New"





Unlinking Navigator and CarePass Accounts Modal






If a user chooses to unlink his Navigator/ CarePass accounts, he is notified that he will no longer earn points towards CarePass incentives.

Added "if eligible" to the line regarding Incentives"






CarePass Hub – Incentive notification


